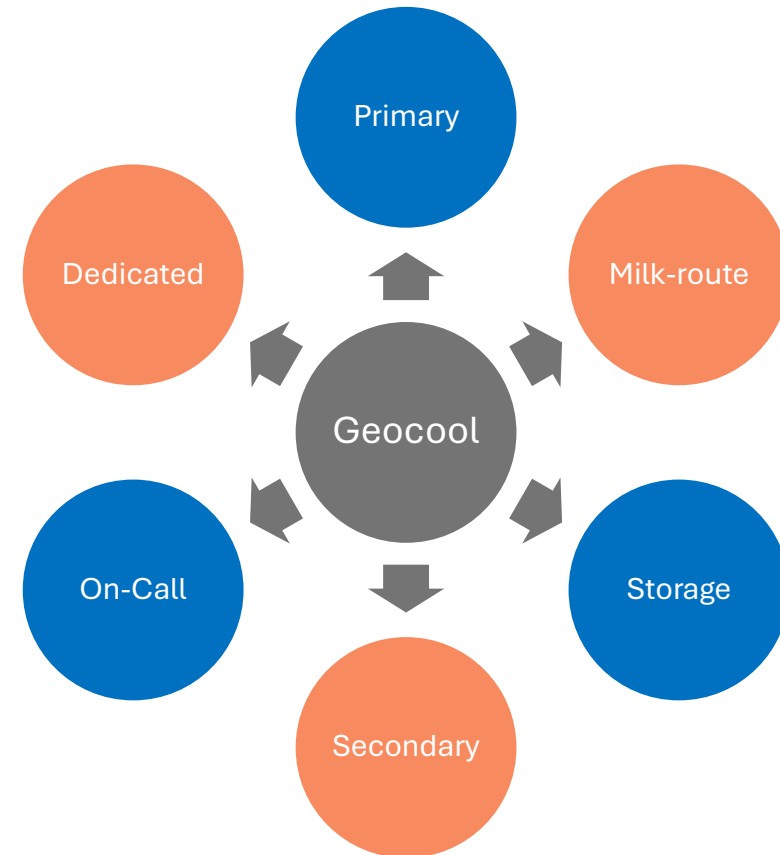

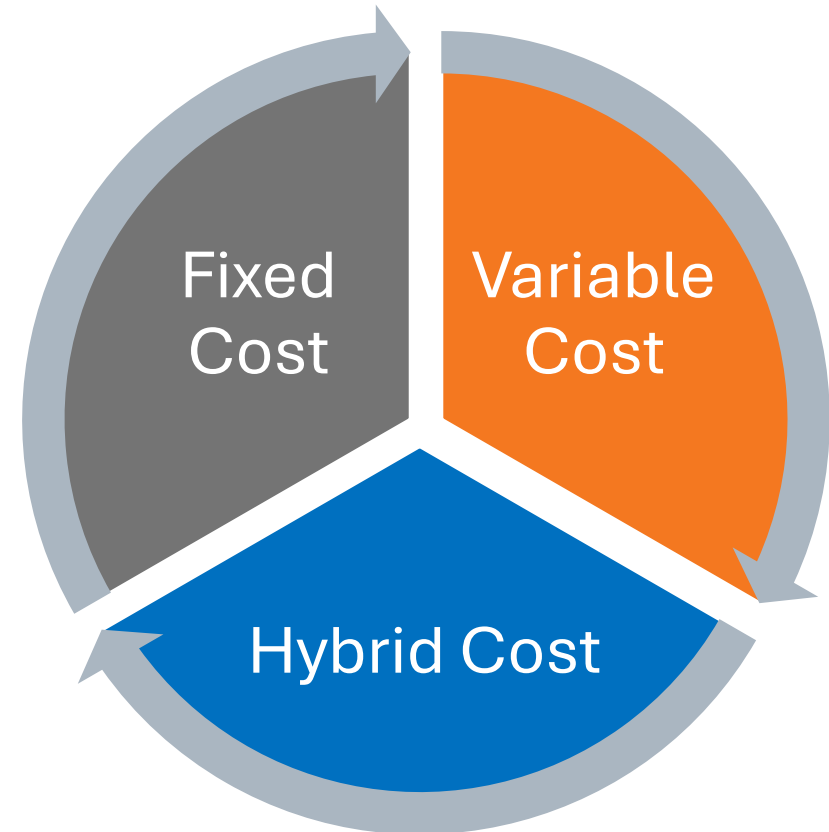

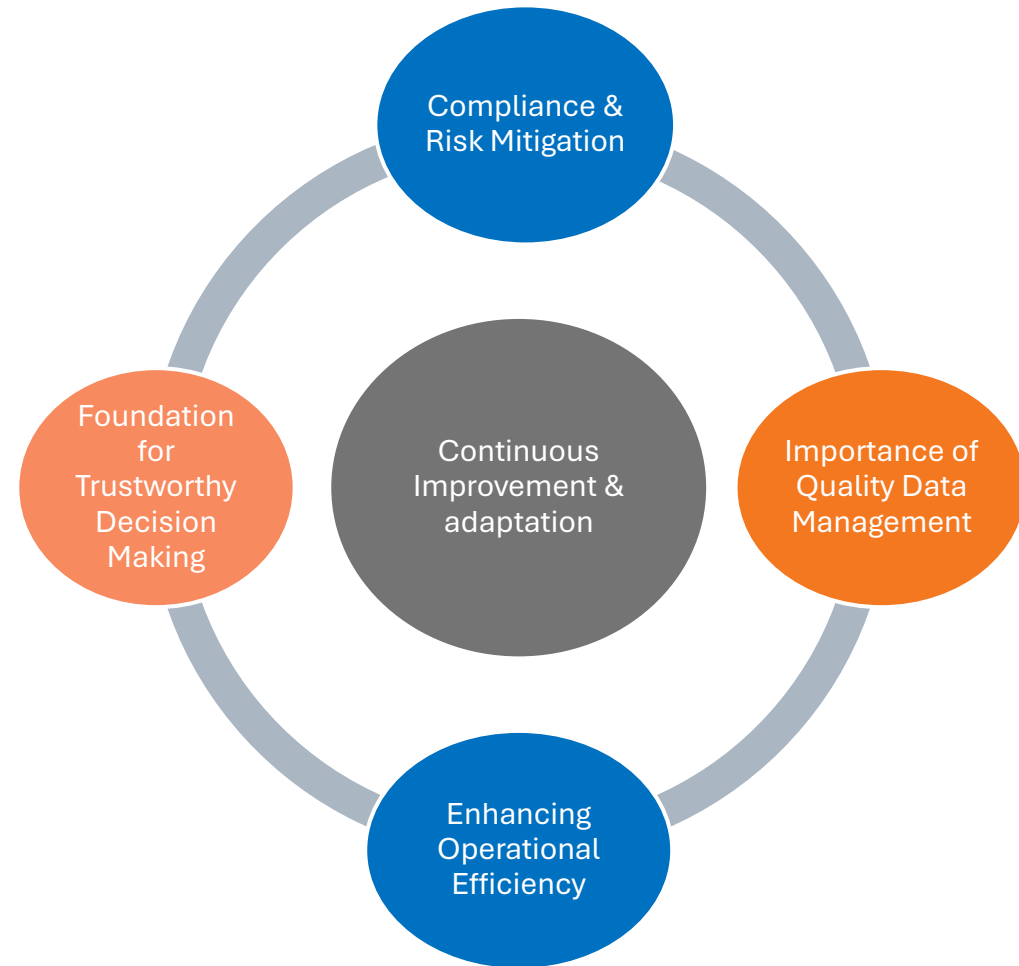
Our Cost Models

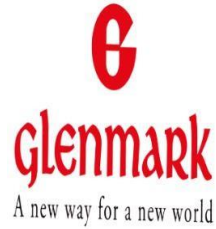

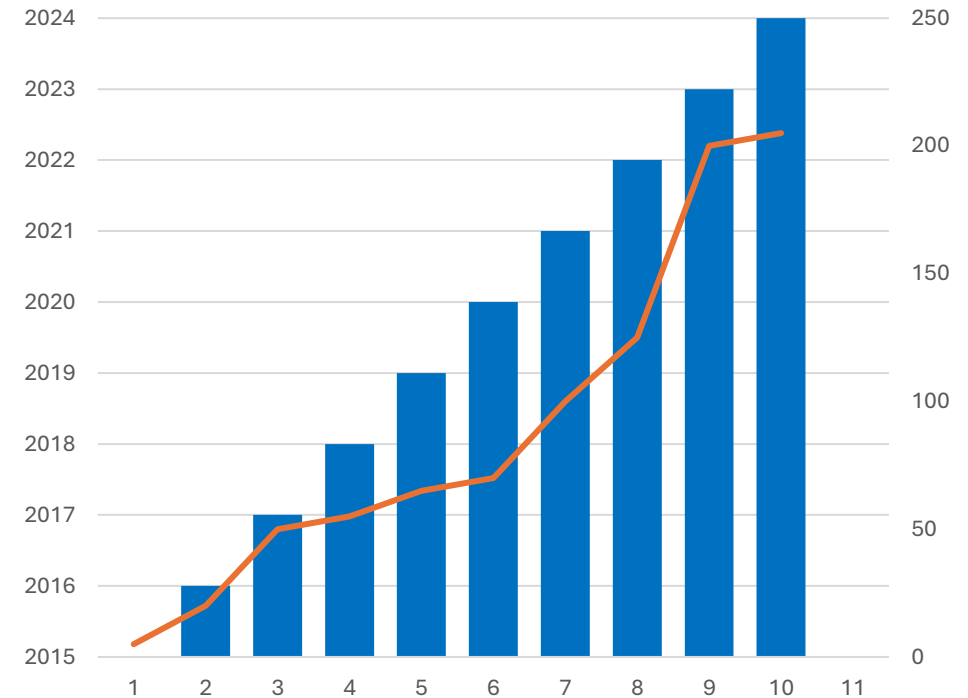
